### PERMANENT INJUNCTION

The following persons are hereby enjoined:

Carmen M. Ceja, Ceja Enterprises, Inc., Ricardo Morales, Mitizie Morales, Yolanda Larrea, Adeline Miranda.

#### Conduct Proscribes by this Injunction:

None of the above-described persons or parties shall engage in the following conduct:

No party subject to this injunction shall engage in the Unauthorized Practice of Law, under Tennessee or Eederal Law in effect at any time.

Unauthorized Practice of Law, under the terms of this injunction includes, but is not limited by the following the following acts:

Advising, Assisting, Aiding or Facilitating any person, who has paid valuable consideration in the selection of any form by the U.S. Immigration Service, including the Department of Homeland Security, USCIS, it's predecessor, successor, Tennessee Department of Labor, U.S. Department of Labor where the forms are for the purpose of obtaining an immigration benefit, including but not limited to labor certification, and Temporary Protected Status.

The above prohibited conduct includes the study of the personal facts or circumstances of any third-party and the study of the law, procedures and policies of the immigration service, Department of Homeland Security, U.C.S.I.S or any predecessor agency, or the Department of Labor, for the purpose of benefiting any third-party who has paid valuable consideration, and who seeks an immigration benefit and the giving advice of how that benefit may be obtained, coupled with the representation to the public any third-party that the enjoined person or party is authorized or qualified to advise the public of how to obtain said immigration benefit.

The above prohibited conduct shall not prevent any of the parties from interpreting or translating information from a form or other material for the benefit of a client. Nor shall any party be prohibited from interpreting information and assisting in the filing of any of these forms, provided that the parties are acting as translators or interpreters and not giving legal advice or assisting in form selection.

Parties who are also a Notary public and not an attorney licensed in Tennessee shall be enjoined from the following conduct:

A Party who is not an attorney licensed to practice law in this state who advertises in any language the person's services as a notary public by radio, television, signs, pamphlets, newspapers, telephone directory or other written or oral communication, or in any other matter, shall include with such advertisement the following notice in English and in the language used in the advertisement. The notice shall be of conspicuous size and shall state:

"I AM NOT AN ATTORNEY LICENSED TO PRACTICE LAW IN THE STATE OF TENNESSEE, AND I MAY NOT GIVE LEGAL ADVICE OR ACCEPT FEES FOR LEGAL ADVICE."

An advertisement on radio or television must include substantially the same message, if the party advertises the person's services as a notary public.

No Party shall advertise the services of "Notario Publico", "Notario", Notaria Publica" or "Notaria".

Ceja Enterprises shall post a disclaimer of association between the parties and Michael Sneed in a conspicuous place in the office of Ceja Enterprises in Spanish and English. Ceja Enterprises shall post a disclaimer of association between the parties and Michael Sneed in any advertisement when they advertise together.

No party, shall advertise services at any location where any non-lawyer party is employed or provides services using the following words or phrases, in any language, or under any literal

translation of other languages indicating substantially the same services, unless the party is employed by a licensed attorney:

"Immigration Specialists"

"Attorney or Lawyer"

"Logal Documents"

"Courts"
